Chand Accessory Dwelling Unit

Gary Clausen - $580 \, 8^{th}$ Street – Expressed his support for the proposal, but was concerned about the sewer easement.

Dipakh Chand – Applicant – Stated that the home would be about 4,252 square feet in size, 5,245 square feet with porches. Mr. Chand noted the structure was permitted by Bill Bullock to be four feet away from sewer on north side because no building is located on the south side.
